MASSACHUSETTS HOSPITALS ARRANGED ALPHABETICALLY ACCORDING TO CITIES

Effective October 1, 2017, the "reasonable fee" for a copy of a medical record, in accordance with G.L. c. 111, § 70, shall be calculated as follows:

Base charge of not more than \$23.89 per request; plus

\$.81 per page for the first 100 pages, and \$.41 per page exceeding Page 100
